







Course Section Instruction Modes & Definitions

Instruction Mode:	Definition:	Examples:
<p>On-Site (P)</p> 	<p>All or the majority of class meetings for the section occur in a classroom or other on-site environment.</p>	<ul style="list-style-type: none"> - All class meetings are delivered in a classroom on campus. - A video/web conference course streams from one classroom to another and requires students to be present in the classroom to watch and interact in real time. -A flipped class where learning content is online, but classes meet in person for hands-on, experiential activities.
<p>Blended (BL)</p> 	<p>A course section where approximately half of on-site class meetings are replaced by online activity.</p>	<ul style="list-style-type: none"> -Delivery is a consistent mix of scheduled face-to-face class meetings and asynchronous online activities. - Class meets on site once per week, supplemented with additional online asynchronous learning activities.
<p>Online Low Residency (OL)</p> 	<p>An online course section with minimal on-site requirements.</p>	<ul style="list-style-type: none"> -A seminar or capstone class that only meets a couple of times a semester as a group, with asynchronous work the rest of the semester. - All class meetings are completed fully online with the exception of two in-person exams or a final presentation on campus.
<p>Online Synchronous (OS)</p> 	<p>A course section where 100% of course activity and class meetings are completed online with required video or audio meeting times. OS courses may be a blend of synchronous meeting times and asynchronous activity that replaces course meetings.</p>	<ul style="list-style-type: none"> - A fully online course section that requires consistent online class meeting times between faculty and students at the same time, using Zoom or in another online meeting tool. - The class may have a scheduled online class meeting one day a week, and replace other weekly meeting times with online, asynchronous activities.

Instruction Mode:	Definition:	Examples:
Online Asynchronous (OA) 	A course section where 100% of course activity and meetings are completed online , with no required online meeting times. OA courses may be partially or entirely self-paced.	<ul style="list-style-type: none"> - On-site course section records each class meeting and allows students to complete the work entirely through watching recorded classes each week (listed as a separate section from on-site section). - A fully online course requiring students to complete a set number of assignments, a midterm, and a final exam. All course materials and exams are self-paced and online.
Hyflex (HF) 	A single course section designed to simultaneously meet an array of student preferences and needs, with on-site, online, and delayed viewing options for each class meeting throughout the semester.	<ul style="list-style-type: none"> - A single course section that allows students to attend class meetings in the classroom, calling in via Zoom during class meeting times, or watching a recording of the class meetings.

Useful Terminology:

Asynchronous: Asynchronous classes deliver information with a time lag. Delivery methods can include posing learning content online, utilizing a discussion board or collaborative document to connect with peers, communication via learning platform announcements, and submitting assessments and receiving feedback online.

Synchronous: The word synchronous means working together at the same time. Although there may be some learning and communication completed online, there will be regular, scheduled course meeting times.
